BREED-GROUP-BEST IN SHOW

Competition is offered for dogs & bitches entered and exhibited in the puppy classes to compete for Best of Breed Puppy through Best in Show Puppy. Puppies that win Best of Breed or Best of Winners in the regular conformation classes are automatically Best of Breed Puppy.

BEST LAGNIAPPE CLASSIC PUPPY COMPETITION

Saturday, August 3, 2013 • Immediately following Best In Show judging.

This competition is open to the Thursday, Friday and Saturday Best Puppy in Show winners. The winners from each day will be judged by a panel of three judges that will be announced before the Best in Show judging on Saturday. The Best Lagniappe Classic winner will receive a \$100.00 prize.

(If a Metairie Kennel Club member's puppy wins Best Puppy at the Friday show, they are eligible to compete in the Best Lagniappe Classic Puppy Competition on Saturday.)

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) first place wins in an Open Class, with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1-October 31 of the following year. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

There will be **NO SPACE** for unentered dogs at these shows.

After loading & unloading, vehicles must be moved elsewhere. No parking is allowed immediately adjoining the loading & unloading areas.

No grass mats allowed inside the building.

No baby strollers allowed inside the building.

Crating of dogs is permitted at ringside only during their breed judging.

No soft sided crates allowed in show building.

Positively no private exercise pens or 2x3's will be allowed inside the building. Private exercise pens are allowed outside the building only & must be kept clean by the owners. All exercise pens will be removed, either voluntarily by the owner or by the Show Committee. All Show Committee regulations & decisions & all regulations governing the use of this facility will be strictly enforced.

No exercise pens allowed on back dock except where marked with tapes & sign.

All crates must be stacked & the individual clubs reserve the right to define crate & exercise pen areas.

Crating & grooming will be allowed in the designated areas only. The Show Committee reserves the right to limit the number of grooming tables per handler.

Absolutely NO GROOMING allowed in Hall C (carpeted area).

All posted regulations of the Pontchartrain Center will be strictly enforced.

No outside food or beverage may be brought into the building.

Dogs are not permitted in the rest rooms, food and/or shower areas.

Neither the show-giving clubs nor the Pontchartrain Center will be responsible for the safety or well being of dogs or other property left at the site.

Exhibitors will be responsible for maintaining clean conditions around the space where they groom, especially those with breeds which require an abundance of powdering and/or clipping. Exhibitors should have clean up equipment with them.

All passageways must be kept open; grooming & crates are not allowed in walkways. Aisles will be marked for easy access. Aisles, grooming & crating areas will be designated.

All regulations governing the use of this facility & all regulations & decisions of the Show Committee will be strictly enforced, including any not recorded in this premium list.

At the sole discretion of the judge, the following breeds may be judged on a ramp: Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Chinese Shar-Pei, Chow Chows, Keeshonden & Polish Lowland Sheepdogs. Ramps are expected to be used for Basset Hounds and Bulldogs. Ramps may be used in emergency situations to judge any breed. (In an emergency situation, an exhibitor does have the option of withdrawing their entry and receiving a refund)
